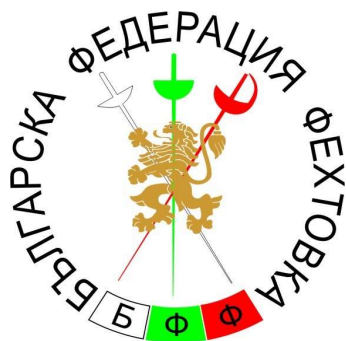

ENTRY FEE

The entry fees are fixed at 25 Euro per fencer for the individual event to be paid to the organizers at the moment of registration (FIE Regulations).

ENROLMENT

The entry of the names of the fencers and all possible replacements must be made via the FIE website 7 days before the competition at the latest (midnight Lausanne time).

REFEREES:

In accordance to the FIE Rules the number of FIE A or B Grade referees that must accompany teams to competitions is:

<i>1–4 fencers</i>	<i>No obligation to provide a referee</i>
<i>5–9 fencers</i>	<i>One referee</i>
<i>10 or more fencers</i>	<i>Two referees</i>

For junior A Grade competitions, the name (s) of the referee(s) (who must have an FIE category in the weapon of the competition for which they are entered) must be notified via the FIE website 7 days before the competition (midnight, Lausanne time).

Should a national federation not provide the required number of referees, a fine (cf o.86, table of financial penalties and fines) will be inflicted on it.

ANTI-DOPING CONTROL

Doping Control will be carried out in accordance with the FIE rules.

Sanitary protocol: According to FIE rules.

REGISTRATION FOR THE COMPETITION

Every participant MUST undergo a RAT. This operation is subsidized by the FIE. The tests are free to athletes and referees. Supplementary people must pay for the tests. People who suffice the Bulgaria "Covid-check" regime (Vaccinated, healed or tested) will not need to repeat the test. According to the current situation in Bulgaria, depending of the Covid situation, it is possible to be necessary to repeat the test. Identification of tested people is done via a bracelet. Losing the result of test and the bracelet will require retesting for a fee (20€). Being present in the competition without bracelet is associated with not having been controlled. It is an infringement to Covid regulations in Bulgaria and may be pursued by law enforcement. Authorities will be able to control at any moment. Also note that the validity of the RATs done at the competition are only valid for the event.
