**ENTRY:** The World Cup is open to all fencers with a 2022-2023 FIE licence. Participation in this competition is subject to art. o.54 of the FIE Organisation Rules.

Entries being closed at the deadlines mentioned in the article (o.54.2), **the competition organiser must establish the list of the exempted fencers and the pools according to art. o.31.2 and o.31.3 of the FIE Rules.**

No changes can be made concerning the 16 exempted fencers whose nomination had already been communicated.

***The list of attending fencers is the list downloaded latest at 3 pm the day before the competition, according to art. o.31.2 of the Organisation Rules.***

**REFEREES:** The costs of the referees, who are chosen by the FIE, shall be borne by the Organising Committee. Delegations do not have to bring referees.

**FORMAT:** The matches take place according to the FIE Rules. An information kit for delegations will be published on the website of the

organiser [www.fechtertage.de](http://www.fechtertage.de) and of the FIE [www.fie.ch](http://www.fie.ch) latest 2 months before the beginning of the competition.
