



## Invitation to Budapest Cup Cadet Circuit Competition”

**International Cadet competitions (part of the European Cadet Circuit) are going to be held on 13-14 November 2021 in Budapest by the Hungarian Fencing Federation.**

1. Location: Hungexpo, building "G" (1101 Budapest, Albertirsai út 10.)

3. Fencers: **born on 01.01.2005 or later can participate in the competitions.**

4. Accreditation: **fencers must be entered to the competitions by their national federation through the EFC website. **Maximum 5 teams/nation are allowed to enter each event!****

**The entry fee is 20 EUR/ person, 60 EUR/ team**

**All referees must be entered through the EFC website by their national federation as the fencers!**

If the referee quota requirement is not fulfilled, **500 Euro** has to be paid for every missing referee.

6. Formula of the competition: FIE JWC formula, i.e. one round with pools followed by direct elimination table without repechage

7. The poules will be announced on the day before the competition; all fencers should be presented at the piste according to the schedule.

8. Equipment: **No name on the back of the fencers is required but for security reasons FIE equipment must be used** (800 NW closes, 1600 NW masks, under wear of 800 NW and FIE homologated blade)

15. A referees' seminar will be held on Saturday and Sunday at 08:00 by EFC Delegate who will also provide evaluation of all referees during individual competitions.

Participation of all referees at this meeting is mandatory.

16. COVID regulations: EU Digital COVID Certificates are accepted.

Otherwise entry to the territory of Hungary in passenger traffic is only allowed to pursue business or economic activities (including sports). Participants need to provide an official PCR test result (in English) to the border officials upon arrival to Hungary. The sample taken must not be older than 72 hours at the time of arrival.
