	Access to the competition site will only be granted to persons who - have received their second vaccination (with Johnson & Johnson only one vaccination required) at least 14 days before the start of the event; only vaccinations with vaccines approved in the EU are recognised (e.g. not Sputnik V or Sinovac); or - have recovered from a proven COVID-19 infection, provided the infection did not occur more than six months previously - if the infection was more than six months ago, they must provide evidence of a single vaccination; - have a negative test for the Corona virus, whereby a certified rapid antigen test must not be older than 24 hours and a PCR test must not be older than 48 hours. The relevant time is the start of the
	tournament as stated in the announcement. All participants (referred not only to fencers) have to print, sign and bring to the competition "COVID-19 ACKNOWLEDGEMENT OF RISK AND RELEASE FROM LIABILITY"
