Entries: Open to all fencers with valid 2021-2022 FIE License.

No fencer is allowed to take part in an official event of the FIE unless he or she is at least 13 years old on 1 January in the year of the competition.

Fencers taking part in all the official FIE Junior competitions, individual or team, must be under 20 years old at midnight on 31st December of the year preceding the year in which the competition takes place (cf o.80).

Entries of fencers, teams and referees can only be made at the FIE website, www.fie.org, respecting the deadlines specified in the FIE Rules (cf. o.54).

Participation: Each national federation may enter a maximum of 12 fencers. The organising country may enter up to 20 fencers plus the number needed to make up the pools.



Contest: Epee women.

Formula: One qualifying round of pools, a direct elimination table to qualify for a final by direct elimination (cf. o.35-o.41).

Inscriptions: Following FIE rules, only through FIE site available, 7 days before the competition at latest.

Entry fee: according with the FIE rules 25 €, to be paid at registration before de start of the competition.

Referees: According to the FIE rules, the referees must be provided by the teams for the competition as follows:

1 to 4 fencers	No obligation to provide referee
5 to 9 fencers	1 referee
10 or more fencers	2 referees

Doping Control: Will be carried out according to FIE rules.

Entry in Spain:

All passengers arriving in Spain by air or sea, including those arriving in transit to other countries, must complete a Health Control Form before departure and obtain their QR to present it at boarding and at health controls on arrival in Spain:

- By air: via the website <https://spth.gob.es> or the Spain Travel Health - SpTH- application (Android, iOS).



In addition to the Health Control Form, passengers **must present a certificate or document certifying vaccination, diagnostic test for active infection (PDIA) or recovery from COVID-19**. These certificates will be different if they have been issued in a country of the European Union (EU Digital COVID Certificate) or in a third country.

COVID-19 certificates of vaccination, diagnostic tests or recovery issued by countries with which the EU has established equivalence will have the same status as an EU DCC. The accepted vaccines are those produced by Pfizer-Biontech, Moderna, Astra-Zeneca, Jansen / Johnson & Johnson, Sinovac, and Sinopharm, which are those that, at the moment, are authorized by the European Medicines Agency or are included in the list of use of emergency of the World Health Organization

The Spanish High Council of Sports will issue the corresponding certificate if an athlete does not have any of these documents (vaccine or diagnostic test or COVID recovery certificate) and meets the requirements. For that purpose, we will need the following data:

- name and surname,
- passport number,
- and country from which you are traveling.

COVID19 Protocol:

Following the rules of the Spanish government and applying the FORMIR guidelines of the FIE the following protocol will be enforced:

1. Rapid Antigen Test (RAT)

Every participant must undergo a Rapid Antigen Test (RAT). This operation is subsidized by the FIE. The tests are free to athletes and referees. Supplementary people must pay for the tests.

Identification of tested people is done via a bracelet. Losing the bracelet will require retesting for a fee (25€).

Being present in the weapon control and in the competition without bracelet is associated with not having been controlled. It is an infringement to covid regulations and may be pursued by law enforcement. Authorities will be able to control at any moment.

Also note that the validity of the RATs done at the competition are only valid for the event.

2 . Departure Test

If you need a departure test you will need to make a reservation with the OC. The tests costs 90€ and will be at your charge.

Tests will be done on Friday 17.12.2021 between 09:00 and 17:00 (results available at 23:00) and Saturday 19.12.2021 between 09:00 and 19:00. (results available before 14:00 the next day).



These timetables could be modified if the number of PCR requested justified the renting of a mobile laboratory.

To guarantee that we will be able to handle the required testing volume you need to obligatory communicate the number of the required tests by November 29th 2021 latest.

We will then confirm you this number and send you a form where you will need to put in the names of the people to be tested. You will need to send us this form by December 8th 2021 latest.

No test can be guaranteed that had not been registered within the deadlines.

Departure tests are conducted by the Laboratory EUROFINs MEGALAB.

2. Positive RAT

The OC is required to transmit the full dataset of every person tested positive to the authorities. Legislation requires that persons tested positive be isolated immediately. The isolation will last until the authorities lift it or a negative PCR-test is available.

If a RAT returns positive the tested person must immediately go to his room. If there is enough time a PCR test will be done to control the result of the RAT.

No PCR can be done on Friday after 17:00.

Hence if a person tests positive at a RAT after these deadlines the result is final and the person must stay in the room until further notice.

Entries: Open to all fencers with valid 2021-2022 FIE License.
No fencer is allowed to take part in an official event of the FIE unless he or she is at least 13 years old on 1 January in the year of the competition.

Fencers taking part in all the official FIE Junior competitions, individual or team, must be under 20 years old at midnight on 31st December of the year preceding the year in which the competition takes place (cf o.80).

Entries of fencers, teams and referees can only be made at the FIE website, www.fie.org, respecting the deadlines specified in the FIE Rules (cf. o.54).

Participation: Team participation is open to all countries and limited to one team per weapon per country.

Contest: Epee women.

Formula: Integral direct elimination with a direct elimination table, which may be incomplete. All places in the table up to 16th place will be fought for. From 17th place onwards teams will be classified, within each round of the table, according to their initial place in the table. The first four teams will be placed in the direct elimination table according to the current official



team ranking of the FIE (cf. o.86); the remaining ranked teams will be placed in the table by drawing of lots in pairs. The teams that are not classified will occupy the last places in the table, and will be separated by drawing of lots (cf. o.42-o.47).

Entry fee: according with the FIE rules 150 € to be paid at registration before the start of the competition.

Inscriptions: Following FIE rules, only through FIE site available, 7 days before the competition at latest.
